**Sub:** Re-engagement of Retired Railway Gazetted Officers in South Central Railway, Construction Organization in exigencies of services.

In terms of Railway Board's letter under reference and with the approval of the Competent Authority, applications are invited from interested and willing retired Junior Administrative Grade (JAG), Senior Scale (SS) and Junior Scale (JS) Officers of South Central Railway for re-engagement as Consultants in South Central Railway/ Construction Organization in view of exigencies of services. Department wise vacancies as Consultants are as under:-

2. Interested and willing retired Gazetted officers (JAG/SS/JS) of South Central Railway may apply for re-engagement as Consultants, accepting the following terms & conditions:-

**Terms and Conditions**

- Suitability/competency of the Retired Officials shall be adjudged before such re-engagement.
- The engagement of consultant shall not be considered as a case of re-employment.
- Maximum age limit of the engagement shall be 65 years.
- The period of engagement shall be initially for one year and further extendable as per requirement of the administration.
- While re-engaging such officers, medical fitness of the appropriate category shall be obtained from the designated authorities as per existing practice.
- Re-engaged officer shall not be entitled for requisites such as HRA, CCA, Transport Allowance, Residential accommodation etc. However, when required to travel in connection with official work, TA/DA admissible to regular Officials working in the same Grade will be admissible.
- 12 days leave in calendar year on pro-rata basis is admissible.
- The designation shall be Consultant followed by (trade name) as indicated above.
- Re-engaged officer shall be discharged immediately on joining of selected candidates (s) from UPSC or department selection as per the recommendation of PHOD/CHOD concerned.
- Re-engaged officers shall be given responsibilities as detailed in Annexure - I

- (k) The consultant shall not divulge any information gathered by him/her during the period of assignment related to the organization to anyone who is not authorized to know /have the same.
- (l) They will not be made in-charge of the unit like Branch Officer in the Division or be authorized to issue any safety certificate.
- (m) Re-engagement officers shall not be given the financial and D&R powers and shall not be authorized to issue any safety certificate.
- (n) Other terms and conditions including the monthly remuneration of a retired Railway officer being re-engaged will be governed by instructions contained in Railway Board's letters dated 25/10/2018, 20/12/2018 and 24/10/2019 and further instructions issued from time to time.
- (o) The Retired Officer found suitable for re-engagement shall be ready to serve anywhere in South Central Railway as per the discretion of PHOD of the concerned department.
- (p) The Officials who were removed/dismissed or compulsory retired as a result of Disciplinary action are not eligible for re-engagement.
- (q) The re-engaged retired officials shall sign an agreement of confidentiality with the Railway containing a clause on Ethics and Integrity.
- (r) The re-engagement can be terminated without any notice and without any explanation or any reason.
- (s) The period of contract will be up to One year from the date of engagement or attaining the age of 65 Yrs whichever is earlier.

**3. How to apply:-**

The vacancy notice is at Annexure-I. Eligible and interested retired JAG/SS/JS officers may apply as per the application format at Annexure-II. The duly filled in application should be sent to the "Senior Personnel Officer (Construction), Office of the Chief Administrative Officer, Construction, Ground Floor, Annexe to Rail Nirman Nilayam, South Central Railway Secunderabad - 500071 in an envelope. The envelope should be super scribed with "Application for the position of Consultant".


The application should reach latest by 28/04/2023.

- (v) Two copies of passport size photograph.


