Sub: Gazetted Arrangements in Legal Department of General Administration.

In pursuance of Hon'ble CAT/HYB's orders dated 08.04.2018 in OA No. 21/809/2018, as upheld by Hon'ble High Court of Telangana, Hyderabad in WP No. 16590/2019 vide their orders dated 28.03.2022, Smt P.Umadevi, Ex.CLA, SDGM/O/SC in Level-7{Level-9/(PB-2+GP:5400/-)under MACPS} who retired from Railway Service w.e.f. 30.06.2016 on superannuation, is promoted to the Group'B' post of Law Officer in Level-8 of 7th CPC Pay Matrix with effect from 30.05.2016 for the purpose of retiral benefits.

Smt P.Umadevi, Retd CLA,SDGM/O/SC is eligible for the following benefits on her promotion to the Group'B' post of Law Officer in Level-8 of 7th CPC Pay Matrix.

1. She will be eligible for Post Retirement Complementary passes (PRCs) on the same scale as applicable to Gr'A' & Gr'B' Officers as prescribed in Schedule - IV of Railway Servants (Pass) Rules, 1993.
2. She will be eligible for Post Retirement medical facilities under RELHS on par with Gr'B' Officers retired in Level – 8 of 7th CPC Pay Matrix.
3. She will not be eligible for any pay fixation in the Gr'B' post of Law Officer in Level-8 since she was granted financial upgradation to Level-9 under MACPS prior to 30.05.2016. Consequently, there shall not be any revision of the retirement benefits arranged in favour of Smt P.Umadevi at the time of her superannuation on 30.06.2016.
