Consequent to the acceptance of his voluntary reversion to the substantive Non-Gazetted post of Public Prosecutor in Level-7 of 7<sup>th</sup> CPC Pay Matrix by Railway Board vide their Letter No. RB/Prosecution Cell/Trans./2-Part-3 dated 23.06.2023, Sri Umesh Chand, Senior Public Prosecutor/GTL in Level-8 of 7<sup>th</sup> CPC Pay Matrix, is reverted to the substantive post of Public Prosecutor, Level-7 and is transferred to Northern Railway on his own request.

Sri Umesh Chand, JS/Gr'B, Sr.PP/GTL is debarred for promotion to the Group'B' post of Sr.PP for a period of one year from the date of his request to take voluntary reversion i.e., 14.06.2023. On completion of the period of debarment on 14.06.2024, if Sri Umesh Chand, Sr.PP/GTL again refuses promotion to the Gr'B' post of Sr.PP, his name will be permanently deleted from the Gr'B' Panel of Sr.PP issued vide Rly Bd's Letter No. 2022/Prosecution Cell/ Cdr./01 dated 21.12.2022.

Sri Umesh Chand, JS/Gr'B, Sr.PP/GTL should hand over all the Railway material like CUG SIM, Stores Material, Imprest cash etc., provided to him in the official capacity of the post of Sr.PP/GTL before his relief.

The date on which Sri Umesh Chand is relieved from the post of Sr.PP/GTL should be advised by sending relinquishment reports to all concerned and in triplicate to Dy.CPO/Gaz.
