- 13) Sri S.Appala Raju, SSE/Drg./M/BZA, in Level-8 (MACP) who is empanelled for promotion to Group "B" Post of AEE/ADEE in Level-8 of 7th CPC Pay Matrix vide Panel No. 403/2023 dt.14.08.2023 is promoted to Group "B" service and is posted as ADEE/M/TPTY (PC:04SC8P016) against an existing vacancy. He will also look after the duties of the Jr.Scale post of ADEE/CRS/TPTY (PC:04SC8W006) in addition to his own, till further orders.

The employees at Sl.No.12 & 13 will be on probation for a period of 12 months in terms of Rule 113, Section-F, Chapter-I of IREM Vol.I. The appointing authority will, on completion of the period of probation assess the work of the Officers and if considers that the same is not satisfactory, the officers can be reverted or the period of probation can be extended.

Sri Vishnumolakala Mukesh, SSE/TRD/KCG on promotion to Gr-"B" Service, is eligible for fixation of pay in promotional grade in terms of Rule 1313 (FR 22)l(a)(1) of IREC Vol-I and Railway Board's instructions contained in RBE No: 212/19 (S.C.No:01/2020). Since Sri S.Appala Raju, SSE/Drg./M/BZA is in Pay Level-8 due to grant of MACPS, no further pay fixation is allowed as per extant instructions.

The promotion of the above employees is subject to the condition that they are free from DAR/Vigilance cases and that they are not undergoing any penalty effecting pay in the existing grade as on the date of their promotion.
