

B (Adhoc), ADEN/GS/SC (PC: 03SC8W047) who is under the orders of transfer to Vijayawada Division as ADEN/GS/BZA (PC: 03SC8W063) in terms of this office order No. Gaz/236/2023 dated 24.08.2023, is now posted as ADEN/BPP (PC: 03SC7P011), vice Sri Sirigiri Manikanta, Sl. No. 5 above.
12. Sri Sk. Abdul Nazeer, SSE/W/GTL who has been approved for adhoc promotion to Jr. Scale post of ADEN/AXEN in terms of Para – 208.2 of IREM Vol-I and on his being medically fit for Gr. 'B' - Technical vide CMS/GTL's certificate No. 09/2023/Gaz dated 03.02.2023, is promoted as adhoc ADEN and is posted as ADEN/Gati Sakti/BZA (PC: 03SC8W063) against an existing vacancy.

The pay of Sri K. Durga Sai Krishna, DEN/West/GTL on his promotion to JA grade on adhoc basis should be fixed in terms of Railway Board's instructions contained in RBE No. 127/2019.

The posting of Sri Sk. Abdul Nazeer, SSE/W/GTL on adhoc promotion to Jr. Scale is subject to the following terms & conditions:

- i) The adhoc promotion is purely temporary till the formation of regular Group 'B' panel.
- ii) The adhoc promotion does not confer the employee any right of continuity, seniority or any other consequential benefits except those which are specifically allowed in terms of extant instructions. The adhoc arrangement can be terminated at any time without assigning any reasons.
- iii) His continuation as adhoc ADEN/AXEN would be subject to his performance in the post and in case his performance is found to be unsatisfactory, he will be reverted back to the parent post without assigning any reason there for in terms of Para 208.2 of IREM Vol-I.
- iv) The promotion is subject to the employee being free from DAR/SPE/Vigilance cases and that he is not presently undergoing any penalty that debars promotion.

Since, Sri Sk. Abdul Nazeer, SSE/W/GTL is already drawing his pay in Level-9 due to grant of MACPS, no further fixation is allowed on his promotion as per extant instructions.

The date the above changes take place should be advised duly sending charge assumption/relinquishment reports to all concerned and in triplicate to Dy. CPO/Gaz.
