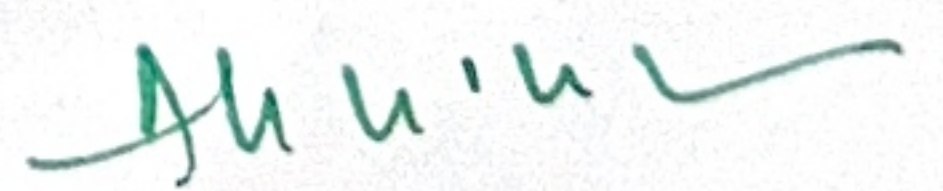

In terms of Railway Boards Lr No. E(NG)I/2018/PM1/4 Dt. 03.08.2022 (RBE No. 91/2022) circulated vide PCPO/SC's Serial Circular No.100/2022, the "KEY" for the written examination held on 19.04.2024 for the post of **Staff & Welfare Inspector** in Level-6, against 35% quota in Personnel Department of SC Division. Calling volunteers from all Departments of SC Division (Except RPF and Accounts Department) is enclosed as **Annexure - I**.

The employees who have attended for the above said written examination (**list of employees is enclosed as Annexure-II**) are advised to go through the "KEY" and make a written representation, if any, against the 'KEY' published and ambiguity in question(s) duly following the conditions as detailed:

1. Publication of "KEY" in Rail Net website <https://scr.indianrailways.gov.in> -> About Us -> Divisions-> Secunderabad -> Departments -> Personnel -> "KEY".
2. The employees will be given only 7 days (including intervening holidays) from the day next to the date of publication of KEY in website to make a written representation with respect to Keys and ambiguity in Questions to the undersigned through their Controlling Officer i.e **29.04.2024**. The Controlling Officer shall send the same with confirmation of identity of the examinee making the representation immediately to the undersigned who in turn will forward the same to the Paper setting Authority within 3 days after due date of receipt of representations duly certifying the identity of the examinee raising the objection.
3. No further time will be given under any circumstances for the exercise detailed at **Para 2**.
4. While making the representation, the authority for the same should be invariably enclosed by the examinee, without which the representation will not be considered.
5. The Controlling Officer shall furnish a **NIL** statement if no representations are received. If there is NIL representation, the same shall be communicated by the Personnel Officer within the stipulated time to the Paper Setting Authority.
6. The keys will also be sent to the respective Evaluator simultaneously during the above process.
7. The Evaluator is also obliged to point out any discrepancies in the Keys to the Paper setting authority through the Personnel Branch Officer concerned.
8. The decision of the Paper setting Authority after this exercise will be final and no further correspondence in this regard will be entertained.
9. The final Keys along with decision taken on the representations received will be published in the Rail net.
10. Evaluation will be started only after the completion of **Para 9**.
11. Decision of the competent authority in case of discounting of any questions or otherwise on account of 'incorrect wording of questions' or 'all answers are wrong' situations will also be communicated along with publishing of final keys.
