

EXPRESSION OF INTEREST (EOI)

The Medical Director of Central Hospital, Lallaguda, invites Expressions of Interest (EOI) from CGHS/ECHS/ESI empanelled and non-empanelled hospitals and diagnostic centres within the jurisdiction of the twin cities (Secunderabad and Hyderabad) for empanelment with South Central Railway for the treatment of Railway beneficiaries, as per the policy laid down by the Railway Board.

Hospitals and diagnostic centers, whether empanelled under CGHS, ECHS, ESI, or non-empanelled, within the jurisdiction of Secunderabad and Hyderabad, are invited to apply on or before 15/07/2024. Applications should be submitted to the Medical Director at Central Hospital, Lallaguda, Secunderabad, 500017, either in person or by post. Applicants must complete the proforma available on the website www.scr.indianrailways.gov.in and comply with the following terms and conditions:

- Rates should be as per the CGHS-2014 Hyderabad prescribed rates based on the classification of hospitals or the hospital tariff, whichever is lower. For items not covered under the CGHS rate list, the hospital should offer a discount on their own rates, including a discount on pharmacy items and free ambulance services for transferring Railway beneficiaries both ways.
- While signing the MoU/Agreement between Railways and the empanelled private hospitals, the format designed by CGHS and modified as per Railway requirements should be adhered to, as it is comprehensive and covers almost all aspects (Authority: Railway Board letter No.2021/H-1/11/10/MoU dated 20/11/2023, available on the website www.scr.indianrailways.gov.in).
- The validity of empanelment is for two years, further extension may be done with mutual consent of both parties.
- Hospitals and diagnostic centers that have submitted their Expressions of Interest (EOI) will undergo inspection by a team of Railway doctors to evaluate their facilities and make recommendations for empanelment. Preference will be given to those hospitals and diagnostic centers offering higher discounts on CGHS, Non-CGHS, Pharmacy, and implants individually. The decision of the competent authority shall be final.
